

GENERAL MEMBERSHIP REQUIREMENTS:

- 1. Must be a resident of or work** in the McQueeney Response area for at least 3 months. (This requirement may be waived for special situations by membership vote)
- 2. Must have 2 members** in good standing act as sponsors.
- 3. Good Moral Character:** **A driving record and criminal history report are required.** Applicant must request their own DPS Type 3 driving record at www.texas.gov (It can be printed immediately for a small fee) and present it to membership committee preferably before membership vote, but no later than 4 weeks of becoming a member. Please do NOT email driving records, they are password protected.
- 4. At least 18 years of age for full membership.**
- 5. A restricted Junior membership** is available for 14 to 17 year olds.
- 6. Six month probationary period.** Before being allowed to respond to calls, these online classes must be successfully completed (with certificates turned in to the fire department): Courage to be Safe (www.everyonegoeshome.com), the ICS-100, ICS-200, ICS-700 and ICS-800 courses (FEMA Independent Study Courses), Traffic Incident Management (<https://learning.respondersafety.com/Clusters/National-TIM-Training-Certificate.aspx>), and FireFighter Cancer Awareness (<https://learn.firefightercancersupport.org/>).
- 7. No experience needed. We will pay for all training and furnish all necessary equipment.** In house training weekly plus many area schools available on weekends. Also a week long school in July is available at the world renowned Emergency Services Training Institute at Texas A&M University, in College Station.
- 8. Attendance requirements:** We meet every Monday evening at 7:00 PM. The first Monday is our monthly business meeting, the second, third, and fourth Mondays are training/drills/maintenance and when available the fifth Monday is a family night. Probationary members are expected to attend all of them to learn about the Department. **A 67% attendance** is required to maintain membership in good standing. After probationary period, excused absences are allowed.
- 9. Time commitment:** at least 3 hours per week for meetings and drills. Other functions and emergency calls may average about 2 plus hours per week.
- 10. Availability:** We are on call 24 hours per day, 7 days per week and respond to a variety of emergencies. Because we are volunteers, members respond whenever they can. We do not want you to jeopardize your regular job or your income but encourage you to respond to as many calls as you can.
